

Dear Parents/Carers

What an extraordinary year it has been full of challenges but so much success and celebration. It has been wonderful to be able to go out on trips, sporting fixtures and to enjoy things like the Prom and Sports Day once again. This letter will set out a few key points for the new academic year but before we focus on that, we wanted to highlight some of the extraordinary things that have happened this year which deserve to be celebrated.

Students attended an industry workshop and the Hammersmith Lyric Theatre following a year of work with Talent 1st. Some of these students had already impressed us during the Christmas Pantomime and we are sure they will again. Our #GoGreen club planted trees on our field and kept us all on our toes in terms of ensuring we are as environmentally sustainable as possible. Next year we will be encouraging everyone to recycle more to earn an investment into extracurricular activities. We have seen lots of trips take place including one to see the England women's team in their opening match at Old Trafford and another to Suffolk University and who can forget our first residentials since the pandemic. We celebrated our talented young people at the Best of British performance at the Embassy, and students "smashed it" at the District Athletics event in Grimsby. The aim of the Behaviour Policy is to ensure that all students learn in a safe and secure environment where high standards of behaviour support learning. Positive behaviour choices are promoted, recognised and rewarded whilst negative behaviours are identified, recorded and sanctioned. We would like to draw your attention to page 21 of the policy regarding After School Detentions (ASD); Depending on the nature of the offence or repeated behaviours a student may receive an extended ASD. An extended ASD can finish anywhere between 16:00 and 18:00. This will be communicated to parent via a phone call and may well take place on the same day as the ASD is issued.

Medication in school

If your child is prescribed medication which needs to be administered during the school day, please ensure you have contacted the main reception and completed the required consent forms. Prescription medication needs to be in the original container with the pharmacy label clearly displayed. We are allowing the administration of some non-prescription medications for students with ongoing conditions requiring occasional pain relief for example. Again, a consent form needs completing on site with the staff in our main reception. Please contact main reception to arrange an appointment.

From September, we will be reverting to students changing for their PE lessons. Students will need to bring their kit into school and get changed for the lesson as they did before the pandemic.

Important Attendance Information for September 2022

Due to the severe impact of Covid 19, the Government have raised expectations of what constitutes full-time education by regular attendance at school. An attendance rate of 97% is required, unless the absence is due to medical reason or otherwise. 95% attendance means that your child will have missed 10 school days over the year, which is a significant amount. In the Supreme Court case of R v Platt, regular attendance is defined as attending on time, and on the days that school has designated, and that even a minute late is an offence. This applies to all children enrolled at school and there is no exception for Sixth Form students.

Please be aware of the following:

Minor illnesses will not be authorised. These are headaches, tiredness, period pains, general aches and pains and minor colds. Public Health England guidelines will be followed, which can be found at: https://www.publichealth.hscni.net/sites/default/files/Guidance on infection control in%20schools poster.pdf Absences over two days will need to be supported by medical evidence. This can be a copy of the prescription, a doctor's note or NHS text.

Unauthorised absences will be forwarded to the Local Authority for consideration of a Fixed Penalty, as at Section 7 below.

Family holidays will not be authorised unless there are exceptional circumstances. What are not exceptional circumstances are: seasonal work, holidays previously cancelled by Covid, family weddings abroad or being unable to take holidays during term time due to work. It is the Principal's decision as to what constitutes an exceptional circumstance. Multiple holidays in a school year will be referred to the Local Authority for consideration of prosecution before a Magistrates Court.

The Education (Pupil Registration) (England) (Amendment) Regulations 2013 have removed the reference to holidays during term time and now provides that a leave of absence during term time will only be granted where an application is made in advance to the school and the school consider that the leave of absence should be granted due to exceptional circumstances relating to that application.

Should you fail to apply in advance for absence due to family holiday or other circumstance then this will be recorded as unauthorised absence. If it has been decided that any holiday applied for does not constitute 'exceptional circumstance' then your child's absence will also be recorded as unauthorised.

Section 7 of the Education Act 1996 places upon parents a duty to ensure their child receives suitable

efficient full-time education either by regular attendance at school or education otherwise. Section 444

(1)(a) of the same Act states that where a parent of a child who knowingly and without reasonable

Justification fails to ensure regular attendance of a registered pupil at that school, the parent of the child shall be guilty of an offence against that Section. The Local Authority may, where necessary, institute legal

proceedings in the Magistrates Court under this section of the Education Act 1996 against those parents concerned. Alternatively, Section 444B of the same Act empowers the Local Education Authority to issue a Fixed Penalty of up to £120.00 per parent, per child. In cases where this duty is not being fulfilled Section 444B of the same Act empowers the Local Authority to issue a Fixed Penalty of up to £120.00 per parent, per child. This letter is a formal Fixed Penalty Warning should you cause your child to be absent from the Skegness Academy without authorisation.

Social Media

Our Academy uses social media (Facebook and Twitter) to celebrate student success and share updates and important information. Recently, on our Facebook page we have seen an increase in the number of negative comments aimed at either the Academy or other users of the page. In September we will be issuing an Acceptable Use Policy, however, in the meantime we would like to remind you that negative, abusive or comments that could be deemed to bring the Academy into disrepute will be deleted with the follower risking being removed from our page and from being able to see and/or interact with our page.

Your child will be allowed on site from approximately 9.30am until 12.30pm. When they arrive at school they need to go to Main Reception where they can collect their results.

If your child is unable to collect their results then they can be collected by their parents /family member, but they will need to bring in written authority from the child.
